Reminder letter regarding the Arrangement of Electronic Dissemination of Corporate Communications

With reference to the notification letter dated 16 December 2024 titled “Arrangement of Electronic Dissemination of Corporate Communications”, SUNEVISION HOLDINGS LTD. Please note that both the English and Chinese versions of all future Corporate Communications will be available electronically on the website of the Company at www.sunevision.com (the “**Company Website**”) and the website of Hong Kong Exchanges and Clearing Limited (“**HKEX**”) at www.hkexnews.hk (the “**HKEXnews Website**”) in place of printed copies (the “**Printed Version**”) and the Company will no longer notify its shareholders of the publication of Corporate Communications on the Company Website. Accordingly, you are encouraged to subscribe for the News Alert service provided by HKEX (currently at www.hkex.com.hk/eng/invest/user/login_e.aspx). Through the News Alert service, subscribers will receive alerts when the Company publishes regulatory notices on the HKEXnews Website or when disclosure of interest filings are made in respect of the Company.

If the Company does not receive a functional email address in your reply, until such time that a functional email address is provided to Computershare, the Company will only be able to send future Actionable Corporate Communications to you in printed form.

All previous requests or instructions to receive Corporate Communications in printed form (if any), which are not revoked or superseded in writing, will no longer be valid with effect from the date of this letter. If you want to receive future Corporate Communications in Printed Version, please complete the enclosed Reply Form and send it to Computershare or send an email to sunevision@computershare.com.hk specifying your name, address and request to receive the Corporate Communications in Printed Version. Please note that such instruction shall be valid until (a) it is revoked or superseded in writing or (b) the Company’s publication of annual report in the following year, whichever is earlier.
