The Trustee has recently made a on-market purchase of Shares pursuant to the Scheme. The purpose of this voluntary announcement is to provide an update on the latest status of such purchase. On 23 September 2026, the Trustee had purchased a total of 142,000 Shares (the “**Share Purchase**”) on the market to hold on trust for the benefit of the Selected Participants pursuant to the Scheme Rules and the Trust Deed. Details of the Share Purchase are as follows:

Average purchase price of each Share:	approximately HK\$0.84
Total consideration of Shares purchased (excluding transaction cost):	approximately HK\$119,000
Balance of Shares held by the Trustee immediately after the Share Purchase (percentage to the total number of Shares in issue as at the date of this announcement):	50,000,000 Shares (7.42%)

The Board believes that the current share price of the Company significantly undervalues the Company’s underlying value, which represents a good opportunity to purchase Shares for future award of Shares under the Scheme. The Company is confident in its own business outlook and prospects. The Company will continue to closely monitor market conditions and its trading share price and instruct the Trustee to undertake share purchase for the purpose of the Scheme as and when appropriate.

The Board will constantly review and determine at its absolute discretion such number of awarded Shares to be awarded to the Selected Participants under the Scheme with such vesting conditions as the Board may deem appropriate.
